North Ridge Country Club is a private club designed to meet the golf, social and dining needs of its proprietary, young adult and social members, their families and their guests with a primary interest in the game of golf.

North Ridge is a very active golf club with numerous events for men, women and mixed play. Two ladies groups are well organized with the Niners on Tuesday and 18-Holers on Thursdays. The Seniors are well represented with a club and tournament schedule of their own. A junior golf program during the summer months is available to children and member's grandchildren.

North Ridge was founded in 1952 primarily as a golf club. Over the years the course has matured into one of the areas premier golf courses. Our course offers a traditional design that is sophisticated and challenging with multiple tee boxes and tournament level conditioning in a park-like setting. There are ample, high quality practice facilities.

The renovated Clubhouse offers full-featured facilities including grill room, main bar, main dining room, multiple banquet and meeting rooms, men's and women's card rooms and scenic patios overlooking the golf course. Social activities include such events as Easter and Mothers Day Brunch, our Annual Mardi Gras Crab Feed, New Years Eve Celebration, Saint Patrick's Day Party and family programs geared towards both members' children as well as grandchildren. The clubhouse is available for use by members for meetings, parties, weddings and other special events. Members may also sponsor the use of the clubhouse by other persons. There are numerous catering options available.

The restaurant is open Tuesday through Sunday for lunch, breakfast Saturday and Sunday mornings. Our crowd pleasing Prime Rib Buffet is the third Thursday of each month. Dinners are served on Friday, Saturday, and Sunday evenings.

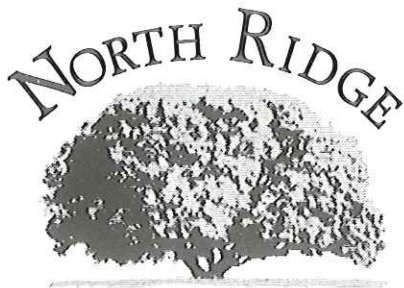

Social Membership ~ Complete details are available in our club by-laws.

Fees: The initiation fee for a social membership is \$1,000. No equity value exists in a social membership and is not returnable. Monthly dues are \$135 and the quarterly food and beverage minimum is \$175.

Privileges: Any social member and spouse and all unmarried dependent children under the age of 21 are entitled to full clubhouse and social privileges. The social member only has limited golfing privileges and must pay a green fee. Play is limited to three rounds of golf per month, only on Tuesday through Thursday and at 2 p.m. or after on Friday, and only at times when guest play is permitted. A social member may invite guests to play on the day he or she plays. The member and guest(s) may use the practice facilities only prior to their time of play.

The clubhouse is available for use by social members for meetings, parties, weddings and other special events. Social members may also sponsor the use of the clubhouse by other persons. There are numerous catering options.
